A RESOLUTION OF THE WINDSOR FIRE PROTECTION DISTRICT, COUNTY OF SONOMA, STATE OF CALIFORNIA, DESCRIBING REINSTATEMENT RIGHTS FOR CURRENT WINDSOR EMPLOYEES IF THE MANAGEMENT JPA DISSOLVES

**WHEREAS** the Windsor Fire Protection District (WFPD) has entered into a Joint Powers Authority (JPA) for management services with the Rincon Valley Fire Protection District;

**WHEREAS** current WFPD employees may promote to management positions within the JPA and become employees of the JPA;

**WHEREAS** there may be a time when the JPA dissolves or is terminated.


**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors of the WFPD agree that if this JPA is dissolved for any reason any WFPD employee so chosen to work for the new JPA shall have the right of return to employment for the WFPD or successor agency of this JPA in accordance with Section VI of the Memorandum of Understanding Between the Windsor Fire Protection District and the Windsor Professional Firefighters Association dated July 1, 2010 through June 30, 2012 concerning seniority and layoffs. *Effective*

**AND BE IT FURTHER RESOLVED** that the Board of Directors of the WFPD agree that should any dispute arise about the order of employment, the Parties or any successor agency will follow Section VII of the above MOU regarding Grievances.

**IN REGULAR SESSION**, the foregoing resolution was introduced by Director Ahlin, who moved its adoption, seconded by Director Magnus, and passed by the Board of Directors of the Windsor Fire Protection District this 16th day of August, 2011 on regular roll call vote of the members of said Board:
